### Subscription Terms

Before signing up to a subscription please note the following key terms;

#### Subscription period

The subscriptions available include monthly rates or annual rates. You will be billed in advance on a recurring and periodic basis, depending on the type of Subscription plan you select when purchasing the Subscription. We offer the following two billing periods;

- ✂ Annual Advanced (for annual subscription packages)
- ✂ Quarterly Advanced (for monthly subscription packages)

At the end of each period, your Subscription will automatically renew under the exact same conditions unless you cancel it or the company cancels it.

#### Subscription cancellations

You may cancel your Subscription renewal either through your account settings page or by contacting the Company directly. You will not receive a refund for the fees you already paid for your current Subscription period and you will be able to access the Service until the end of your current Subscription period. If cancelling by contacting the Company directly, you are required to notify Company within 5 days of subscription renewal to guarantee receipt and action.

#### Billing

We use Stripe to process all subscription payments. You shall provide the Company via Stripe with accurate and complete billing information including full name, address, state, zip / post code and a valid payment method information upon signing up. Should the system require you to re-enter your billing payment method at each renewal, you will action within 5 days of request, or your subscription will be automatically cancelled and removed from the Company service. Should automatic billing fail to occur for any reason, the Company will issue an electronic invoice indicating that you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

#### Fee Changes

The Company, in its sole discretion and at any time, may modify the Subscription fees. Any Subscription fee change will become effective at the end of the then-current Subscription period. The Company will provide You with reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate Your Subscription before such change becomes effective. Your continued use of the Service after the Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.
